

## INSTRUCTIONS TO BIDDERS

Quaid-e-Azam Solar Power (Pvt) Ltd Government of the Punjab (the "Client" ) intends to hire different vehicles on daily & monthly rent for intra/inter city official use during the FY 2015 2016 on Framework Contract (Rate Contract) basis in compliance of PPRA rules. You are hereby invited to submit your tender for the items as detailed in the list of vehicles, subject to the following terms and conditions:-

1. The bidder should submit the bid on the prescribed forms and quote rate of each vehicle in the financial form attached herewith and submit the sealed bid at the place mentioned in the tender notice on or before the date & time mentioned in the tender notice which will be opened on the same day in the presence of representatives of the firms.
2. The procurement will be done under PPRA rules by using single-stage one-envelope method and will be evaluated on Least Cost basis.
3. The bidder should be registered operator in the relevant field and operational office should be in Lahore preferable in the close vicinity of the Clients premises. The bidder should have sufficient fleet of vehicles to meet the demand of the Client. The vehicles offered on rent should be in excellent condition and should not be older than three years.
4. The vehicles will be called as per requirement of the Client. Cars should preferable be petrol fueled. The daily rates should be quoted Booking hours & Mileage running basis. The rates should be inclusive of POL and other expenses & all applicable taxes. The rates of selected bidder shall be valid for at least one year from the date of signing of contract.
5. The call will be issued normally one day before but in urgency two hours before the required time and the duty is expected beyond office hours. The firm will be liable to ensure the availability of the rented vehicles 24/7.
6. The rates should be mentioned in the prescribed form attached herewith. Conditional, ambiguous and cutting or overwriting in any form shall not be accepted.
7. The rates will be evaluated on least cost basis. The contract will be awarded to the single lowest bidder based on overall evaluation/calculation of the rates or per item basis as the case may be.
8. The successful bidder (the firm) will be required to enter into framework contract with the client as per PPRA and other government rules which will remain effective till one year from the date of signing, extendable as per Client's requirement.
9. The firm will be responsible for repair and maintenance of vehicles to keep them in working condition. In case of breakdown of a vehicle the firm will immediately provide thee replacement without any additional cost.

10. The firm shall provide skilled and well-mannered drivers and arrange the replacement of any driver in his absence. The drivers should be well acquainted with the city and intercity locations and roads.
11. The hiring service time & millage will start from the time arrival of vehicle at requisite place and will continue till relieving of vehicle by the Client.
12. The Client will be deduct applicable taxes from the payment, as per prescribed rate of the government.
13. Tender/Bids shall be submitted only on this tender form duly filled, signed & stamped on each page by Chief Executive /Authorized person of the firm.
14. If found guilty legal action may be initiated against black listed firms.
15. Other terms & conditions will be mentioned in the Rate Contract.
16. The Client/Competent Authority may reject all bid or proposals at any time prior to the acceptance of a bid or proposal without incurring any liability thereupon.
