

INVITATION (EOI) PREQUALIFICATION OF CONTRACTORS

"Renewable & other initiatives in Energy Sector -

Pilot Project of Off-grid/Poor Grid Village Electrification in Punjab through Solar Power"

The Government of the Punjab (GoPb) through the Energy Department (ED) intends to provide electricity to Off-Grid Villages of Punjab using Solar Energy (As a Pilot Project), through EPC contractors to facilitate the people of these areas. This will also reduce burden on National Grid and will improve the environmental conditions of Punjab by providing clean energy to these Villages. ED has instructed Quaid-e-Azam Solar Power (Pvt) Ltd. to prequalify firms/contractors for design, supply and installation as well as Operation and Maintenance (O&M) through National Competitive Bidding (NCB) process under the Punjab Procurement Rules, 2014 (as amended from time to time) (PPR 2014) for Off-Grid Solar PV Power Plant at 11 selected villages (the "Project").

Firms/companies/JVs/legal entities (Interested Parties), preferably having relevant registration as per laws of Pakistan, having experts in solar power generation relevant experience may apply along with all the documents as required in PQD. A complete set of PQD (In English) may be purchased (immediately after the publication of this advertisement) by the interested applicants on submission of a written application and upon payment of non-refundable fee of **PKR 1,000/-** during office working hours at the address given below.

The Applications of only those bidders shall be acceptable who have purchased PQD from the Procuring Agency after submission of the prescribed fee.
